1. Who is responsible for managing my information?

This is our Privacy Notice and it explains how we collect, use, share and protect your personal data. We are responsible for the collection and proper management of any personal information you give to us. We will keep your personal details secure and use the information you provide consistently with applicable privacy and data protection laws and the terms of this Privacy Notice.

2. What information do we collect?

3. How do we use your information?

Legal Obligation

We may also use and disclose your personal data without your permission to the extent that we are required to do so for compliance purposes, by any law or regulation, by a law enforcement, governmental or taxation agency or for crime prevention purposes.

5. Who will you share my information with?

In order to provide you with the products and services that we supply we may share your information with:
